Each Proposal must be (a) in accordance with the requirements of the RFP, all of which is incorporated herein by reference, and (b) all of the provisions of IC 5-32, as amended and as applicable to the RFP process, and (c) submitted by a person or entity satisfying the definition of a Construction Manager as Constructor (CMc), as defined in IC 5-32, as amended (each a "CMc").
